#### **FY 2007 CONTINUING RESOLUTION**

Feb 1, 2007: The House passed a \$463 billion spending measure (stripped of earmarks) that would keep the government operating for the remainder of fiscal year 2007. The bill, approved 286 to 140, maintains funding for most federal agencies at 2006 levels, but it adds about \$16 billion for Democratic priorities, including veterans' health care and Pell grants for higher education. The Senate must pass the continuing resolution by Feb. 15 to avert a partial government shutdown. The White House has indicated that President Bush will sign the measure. The measure was passed due to a failure of the last Congress to pass nine of the eleven spending bills.

#### **BIOFUELS**

As the 110<sup>th</sup> Congress gets under way, there is significant momentum behind development of alternative energy sources, including biomass energy and cellulosic

ethanol. The President included a brief mention of the need for alternative energy sources in the State of the Union, suggesting the further development of biofuel from wood chips.

## **CONGRESSIONAL COMMITTEES**

Every two years, Congress begins a new session. The most recent session began on January 4<sup>th</sup> of this year and is the 110<sup>th</sup> session of Congress. Each new session potentially brings with it many changes including changes to Committee and Subcommittee structure and membership. This particular Congress has had a significant amount of change as a result of a shift in party leadership from Republican to Democrat following last November's elections. In the organization meetings prior to the start of the 110<sup>th</sup> Congress and throughout the month of January, Committees have continued organizing. This means assigning members to full committees, creating and assigning Members to subcommittees, determining chairs and ranking members (the lead member of the committee from the minority party), and adopting committee rules. We've included in this edition of FCN (attached at the end of the issue) the rosters of and some information about the committees and subcommittees most relevant to the forest community

## **COUNTY PAYMENTS**

January 4, 2007: In the House, Oregon Representative Peter DeFazio (D-OR), in a bipartisan effort with Rep. Greg Walden (R-OR) and 69 other cosponsors (as of Jan. 23<sup>rd</sup>), introduced HR17, a bill to reauthorize the Secure Rural Schools and Community Self-Determination Act of 2000 for an additional 7 years.

January 11, 2007: In the Senate, Oregon Senators Ron Wyden (D-OR) and Gordon Smith (R-OR) requested that the Administration include funding for an extension of the county payments program in their FY 2008 budget request, which will be released on or before February 5, 2007.

January 24, 2007: Senator Wyden, with 7 cosponsors, introduced S380, a bill to reauthorize the Secure Rural Schools and Community Self-Determination Act. Notably, Senator Larry Craig (R-Idaho) who cosponsored the original law in 2000 did not sign on to Wyden's bill, arguing that Oregon receives too much money under the current formula.

## **WILDFIRE**

Jan 30, 2007: The Senate Committee on Energy and Natural Resources held hearings to examine the status of Federal land management agencies' efforts to contain the costs of their wildlife suppression activities and to consider recent independent reviews of and recommendations for those efforts.

In recent years, the Forest Service's wildfire suppression costs have soared, amounting to over \$1 billion in 3 of the last six years. In November 2006, the USDA Office of Inspector General published the findings of an audit of the Forest Service's wildfire suppression costs, concluding that the escalating costs were largely the result of efforts to protect private property in the wildland urban interface. Additionally, the Government Accountability Office (GAO) has produced three recent reports on wildland fire suppression.

### **AGENCY APPOINTMENTS**

Jan 12, 2007: The U.S. Department of Agriculture announced the selection of Abigail Kimbell as the 16th chief of the Forest Service. Kimbell succeeds Chief Dale Bosworth, who retired on Feb. 2 after 41 years with the Forest Service. Kimbell has been serving as Regional Forester for the Northern Region in Montana, which also includes northern Idaho, and North Dakota. Before becoming regional forester, Kimbell served in the Washington Office as Associate Deputy Chief for the National Forest System, with responsibility for assisting in the development of the Healthy Forest Restoration

### **BUDGET**

President Bush will send his budget proposal for fiscal year 2008 to Congress on February 5, 2007. The budget contains the Administration's funding recommendations for all federal agencies including the Forest Service and the Bureau of Land Management. This release marks the beginning of the appropriations process for FY 2008.

### **FARM BILL**

Jan. 31, 2007: The Administration released their long awaited proposals for the 2007 Farm Bill, with more than 65 proposals corresponding to the 2002 farm bill titles. The proposals contain recommendations for a variety of forestry, conservation and rural development programs. ## **RECREATION ON NATIONAL FORESTS**

On January 26th, the USDA Forest Service announced the convening of a National Review Team to gauge the effectiveness of citizen participation in the Recreation Site Facility Master Planning process. Responding to increased public attention on the Recreation Sites Facility Master planning effort, Forest Service Chief Bosworth charged the national team to conduct a thorough review and make recommendations by April 2, 2007. The team's findings and recommendations will form the basis for broadening the current citizen involvement process.

As detailed in the agency's press release on this issue, "Recreation Site Facility Master Planning is not a decision process. Rather, it is an analysis tool, to encourage dialogue on the changing demands for recreation facilities on national forests and what options may exist to respond to those changes. Open dialogue with communities is an essential aspect in each step of the process."

Deputy Regional Forester Beth Pendleton, of the Pacific Southwest Region, will lead this national review team. Among other things, team members are tasked with assessing public participation activities, methods, products and results from a diverse cross section of the national forests. They are also expected to interview a selection of citizens who have expressed interest in the Recreation Facility Master Planning process.

The organization and jurisdiction of Committees and Subcommittees frequently changes at the beginning of each session of Congress. This is especially the case when a new party enters the majority. The Committee and Subcommittee lists below are the new 110<sup>th</sup> Congress rosters. The descriptions of Committee jurisdictions are from the 109<sup>th</sup> Congress and may change slightly as the current Congress continues to determine this session's structure.

#### Natural Resources:

The House Committee on Natural Resources and the Senate Committee on Energy and Natural Resources have jurisdiction over issues that include public lands and their resources, ranging from timber to mining and mineral leasing. The Committee roster and rosters for subcommittees most important to the forestry community are:
